Client: any professional or capable natural person within the meaning of Articles 1123 et seq. of the Civil Code, or legal entity, who visits the Site which is the subject of these general conditions.

Personal information: "Information that allows, in any form whatsoever, directly or not, the identification of the natural persons to whom it applies" (article 4 of law n° 78-17 of 6 January 1978).

7. Management of personal data.

The Customer is informed of the regulations concerning marketing communication, the law of 21 June 2014 for confidence in the Digital Economy, the Data Protection Act of 06 August 2004 and the General Data Protection Regulation (RGPD: n° 2016-679).

7.1 Persons responsible for the collection of personal data

For the Personal Data collected within the framework of the creation of the User's personal account and his navigation on the Site, the person responsible for the processing of the Personal Data is: Tyche Corp. <https://tyche-corp.com/est> represented by Tyche Corp SASU, its legal representative

As the party responsible for processing the data it collects, <https://tyche-corp.com/> undertakes to comply with the legal provisions in force. In particular, it is the Client's responsibility to establish the purposes of its data processing, to provide its prospects and clients, from the collection of their consents, with complete information on the processing of their personal data and to maintain a register of the processing in accordance with the reality. Whenever <https://tyche-corp.com/> processes Personal Data, <https://tyche-corp.com/> takes all reasonable steps to ensure that the Personal Data is accurate and relevant to the purposes for which <https://tyche-corp.com/> processes it.

7.2 Purpose of the data collected

<https://tyche-corp.com/> is likely to process all or part of the data:

- to enable browsing on the Site and the management and traceability of the services ordered by the user: connection data and use of the Site, billing, order history, etc.
- to prevent and fight against computer fraud (spamming, hacking, etc.): computer equipment used for browsing, IP address, password (hashed)
- to improve navigation on the Site: connection and usage data

- to conduct communication campaigns (sms, email): telephone number, email address

<https://tyche-corp.com/> does not sell your personal data, which is therefore only used for statistical and analysis purposes.

7.3 Right of access, rectification and opposition

In accordance with the European regulations in force, the Users of <https://tyche-corp.com/> have the following rights:

- right of access (Article 15 RGPD) and rectification (Article 16 RGPD), updating, completeness of Users' data right of blocking or deletion of Users' personal data (Article 17 RGPD), when they are inaccurate, incomplete, equivocal, outdated, or whose collection, use, communication or storage is prohibited
- the right to withdraw consent at any time (Article 13-2c GDPR)

- the right to limit the processing of Users' data (Article 18 GDPR)
- right to object to the processing of Users' data (Article 21 GDPR)
- the right to portability of data provided by Users, where such data are subject to automated processing based on their consent or on a contract (Article 20 GDPR)
- the right to define the fate of Users' data after their death and to choose to whom <https://tyche-corp.com/> shall communicate (or not) their data to a third party that they have previously designated

As soon as <https://tyche-corp.com/> becomes aware of the death of a User and in the absence of instructions from the User, <https://tyche-corp.com/> undertakes to destroy the User's data, unless it is necessary to keep it for evidentiary purposes or to comply with a legal obligation.

7.4 Non-communication of personal data

Within the limits of their respective attributions and for the purposes mentioned above, the main persons likely to have access to the data of the Users of <https://tyche-corp.com/> are mainly the agents of our customer service.

Despite our best efforts, no method of transmission over the Internet and no method of electronic storage is completely secure. We therefore cannot guarantee absolute security. If we become aware of a security breach, we will notify affected users so that they can take appropriate action. Security

9.1. "COOKIES"

A "cookie" is a small information file sent to the User's browser and stored in the User's terminal (e.g. computer, smartphone), (hereinafter "Cookies"). This file includes information such as the User's domain name, the User's Internet service provider, the User's operating system and the date and time of access. Cookies are in no way likely to damage the User's terminal.

<https://tyche-corp.com/> is likely to process the User's information concerning his/her visit to the Site, such as the pages consulted and the searches carried out. This information enables <https://tyche-corp.com/> to improve the content of the Site and the User's browsing experience.

Article 9.2. INTERNET TAGS

<https://tyche-corp.com/> may occasionally employ web beacons (also known as "tags", action tags, single-pixel GIFs, clear GIFs, invisible GIFs and one-to-one GIFs) and deploy them through a web analytics partner that may be located (and therefore store information about them, including the User's IP address) in a foreign country.

These beacons are placed both in the online advertisements that allow users to access the Site, and on the various pages of the Site.

This technology allows <https://tyche-corp.com/> to evaluate visitors' responses to the Site and the effectiveness of its actions (for example, the number of times a page is opened and the information consulted), as well as the use of this Site by the User.

10. Applicable law and jurisdiction.
